CASH GIFTS - Outright cash gifts are the common form of giving. Your gift becomes immediately available to support important projects and services here at Emerald Lakes Cooperative. The Cooperative accepts cash and check donations. The donor will be credited with the full amount of his or her cash gift.

BEQUESTS - Your will is a meaningful way to make a charitable gift of lasting value to the Emerald Lakes Cooperative. Through a bequest provision, you can designate a specific amount of money, a percentage of your estate, or the remainder of your estate after other bequests are satisfied. Adding a codicil to an existing will is a simple process that begins by making your intentions known to your attorney.

MEMORIAL AND TRIBUTE GIVING

- Gifts in memory of deceased friends and loved ones or gifts that honor living individuals are gratefully accepted by Emerald Lakes. Such contributions are often used to reflect the special interests of the person honored. Any gift to Emerald Lakes may be designated in memory of or in honor of a loved one. Tangible gifts may be subject to approval.

GIFTS OF APPRECIATED SECURITIES

- If you own long-term securities that have appreciated in value, you may prefer to contribute securities to Emerald Lakes rather than cash.

GIFTS OF LIFE INSURANCE

You may name the Emerald Lakes Cooperative as the owner and beneficiary of a life insurance policy, thus designating your donation to Emerald Lakes.

GIFTS OF REAL ESTATE

Your present park home or other real estate can be donated to this fund. Gifts will be accepted at the discretion of the Cooperative after a review of all relevant factors.
